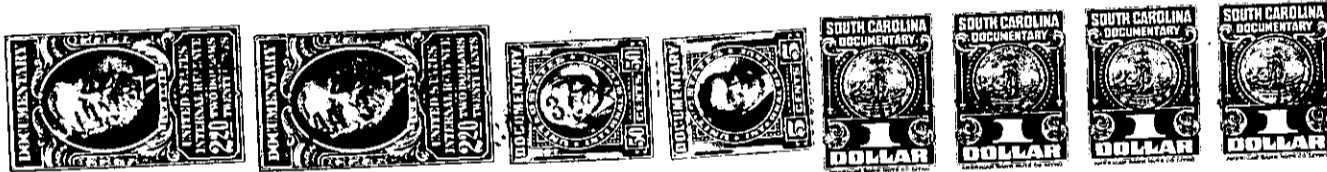

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 41, as shown on a plat of Augusta Road Hills, recorded in the RMC Office for Greenville County in Plat Book M, Page 33, and having according to said plat, the following metes and bounds, to-wit:
