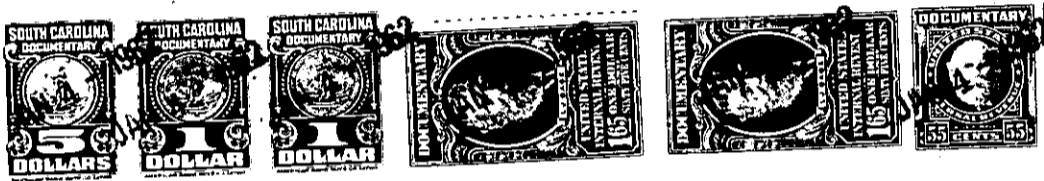
That We, James H. Carrier and ~~Lencar~~ <sup>LANIER</sup> L. Carrier
