

Lot 3: BEGINNING at an iron pin on the East side of Houston Street at a point 101.2 feet from the North-east intersection of Houston Street and Pearl Avenue, and running thence with the rear line of Lots 4, 5 and 6, S. 87-50 E. 117.7 feet to a pin in line of Lot 7; thence with line of Lot 7, N. 3-10 W. 55 feet to a pin in line of Lot 2; thence with line of Lot 2, N. 87-50 W. 111.8 feet to a pin on Houston Street; thence with Houston Street, S. 2-58 W. 55 feet to the Beginning corner.

Lots 4 and 5: BEGINNING at an iron pin at the intersection of Houston Street and Pearl Avenue and running thence with the Northern side of Pearl Avenue, N. 88-44 E. 77.9 feet to the joint front corner of Lots 5 and 6; thence with the line of Lots 5 and 6, N. 3-00 W. 97 feet to the joint rear corner of Lots 5 and 6; thence with the line of Lot 3, N. 87-50 W. 67.7 feet to a point on the Eastern side of Houston Street; thence with the said Houston Street, S. 2-58 W. 101.2 feet to the Beginning corner.
