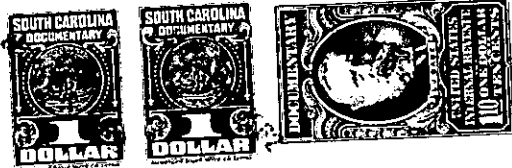
ALL of my right, title and interest in the following described property:
