BRYSON, his heirs and assigns forever:

All that piece, parcel or lot of land in Highland Township, County of Greenville, South Carolina, located about 7 miles North from Greer, S. C., just off the Mt. Lebenon Road on the Eastern side of the road that leads to the T. P. Fitts Estate and being shown as 0.7 of an acre on a plat made for T. P. Fitts Estate by J. Q. . Bruce, surveyor, dated 4-13-60, and this lot being surveyed 5-16-60, and having the following metes and bounds according to said plat which is recorded in the Greenville County R. M. C. Office . This also includes a 20 foot strip as shown on said plat as a dirt road and was being reserved as such, but withdrawn by Thomas J. Fitts, and will be placed along the northern edge of the within property.

Tucker lot; thence due South 200 feet along the line of Tucker to the center of a dirt road (I. P. Set off 25 feet on northern bank), thence along the center of the said road S. 69-41 W., 107 feet to the center of the road that leads to the T. P. Fitts Estate; thence N. 3-25 E., 100 feet along the center of the said road; thence N. 12-34 E., 334 feet still with the center of the said road to the beginning corner.
