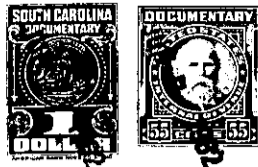

City of Greenville, on the northwest side of Maxcy Avenue, shown as Lot
No. 15-A, and being a portion of Lot No. 14 on a plat of Cochran Heights
recorded in Plat Book HH, Page 13, RMC Office for Greenville County, and
being more particularly described as follows:

BEGINNING at an iron pin on the northwest side of Maxcy Avenue, at the
front corner of Lot No. 16 which pin is 541.1 feet southwest of the
intersection of said Avenue with White Horse Road, and running thence
with the northwest side of Maxcy Avenue, S. 60-52 W. 75 feet to an iron
pin, thence N. 32-47 W. 134 feet to an iron pin; thence N. 59-56 E. 70
feet to an iron pin in line of Lot No. 16; thence with the line of said
lot, S. 34-47 E. 135.5 feet to the beginning.
