BEGINNING AT AN IRON PIN in or near the Greer-Pelham Road and at the joint corner of the within described premises and property now or formerly belonging to E. L. Mayfield and running thence with the line of said Mayfield property N. 67-32 E. 533 feet to an iron pin in the line of property now or formerly belonging to Edgar Burnett; thence with the line of said Burnett property N. 1-27 E. 80 feet to an iron pin in the line of property now or formerly belonging to J. R. Green; thence with the line of said Green property and the line of property now or formerly belonging to Henry E. Bryant N. 68-38 W. 736 feet to an iron pin in the Greer-Pelham Road and in the line of property now or formerly belonging to Margaret Ruth M. Mathis; thence with said Greer-Pelham Road and said Mathis property the following courses and distances: S. 5-45 E. 88.5 feet; S. 9-55 E. 100 feet; S. 15-35 E. 100 feet; S. 22-25 E. 100 feet; S. 27-05 E. 100 feet; S. 34-45 E. 100 feet to the point of beginning.
