(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
these presents do grant, bargain, sell and release unto the said Robert L. White, Jr.,
his heirs and assigns forever:

ALL that house and lot located on the southeastern corner of McGee Street
and East Avenue and known as No. 16 McGee Street in the City of Green-
ville, in Greenville Township, in the County of Greenville, State of
South Carolina and being shown and delineated as Lot No. 16, Block 6,
Page 39 of the City Block Book; bounded on the north by East Avenue, on
the East by Lot No. 15 now or formerly owned by James and Elizabeth
Howard, on the South by Lot No. 17 now or formerly owned by Nannie
Hunter Ashley and on the west by McGee Street and having the following
metes and bounds:

BEGINNING at the southeastern corner of McGee Street and East Avenue and
running thence with the southern side of East Avenue N. 80-45 E. 143.7
feet to corner of Lot No. 15; thence with the line of said lot S. 13-45
E. 74 feet to corner of Lot No. 17; thence with the line of said Lot
S. 77-15 W. 130 feet to McGee Street; thence with the eastern side of
McGee Street N. 21-30 W. 85 feet to the beginning corner.

BEING the same lot of land conveyed to the grantor herein by E. Inman,
Master by deed dated February 11, 1954 and of record in the RMC Office
