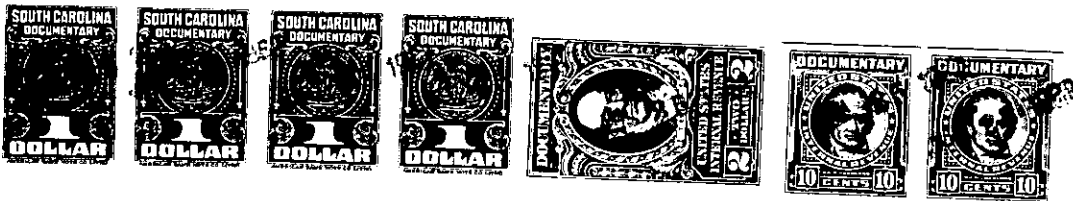
KNOW ALL MEN BY THESE PRESENTS, that W. E. Shaw, as Trustee for W. E. Shaw and W. N. Leslie

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #16, of a subdivision known as Homestead Acres, as shown on a plat prepared by J. Mac Richardson, Engineer, dated November 1959, and recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 35, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Homewood Avenue, the joint front corner of lots #15 and #16, and running thence along the line of these lots, S. 27-11 E. 135.6 feet to an iron pin; running thence S. 53-55 W. 120 feet to an iron pin on the eastern side of Homestead Drive; running thence along the eastern side of Homestead Drive N. 36-05 W. 134.8 feet to an iron pin at an intersection; thence along said intersection which line is curved, the chord of which is N. 14-15 E. 34.9 feet to an iron pin on the southern side of Homewood Avenue; running thence along the southern side of Homewood Avenue N. 64-35 E. 118.6 feet to an iron pin, point of beginning.
