the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **Wooten Corporation of Wilmington, its Successors and Assigns,**

All that certain piece, parcel or lot of land with any improvements thereon, situate, lying and being on the western side of West Castle Road in Pine Hill Village, Gantt Township, Greenville County, South Carolina, shown and designated as Lot 189 on a plat of Pine Hill Village, prepared by R. K. Campbell, R.L.S., dated *July 9, 1962*, and recorded in the Office of the R.M.C. for said County and State in Plat Book *QQ* at Page *168*, and according to said plat being more particularly described as follows:
