KNOW ALL MEN BY THESE PRESENTS, that I, Talmer Cordell

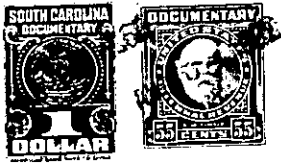
in consideration of Two Hundred and No/100-----(\$200.00)-----Dollars,
