ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being a portion of Lots Nos. 133 and 134 of a subdivision known as Camilla Park, Map 2, as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book M at Page 85, and also being known as a Re-subdivision of Lots Nos. 8, 9, and 10, of the property of Talmer Cordell as shown on a plat prepared by J.
