to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John Burry, his heirs and assigns, all my right, title, interest and estate in and to:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and according to plat of property of grantor and grantee made by R. B. Bruce, surveyor, recorded in Plat Book UU at Page 149, having the following metes and bounds, to-wit:

BEGINNING at a point on the northern side of Cedar Lane Road, which point is 48.6 feet southeast from the southwestern corner of Lot No. 5 and running thence approximately N. 23-46 E. 79.1 feet to the southwestern corner of the drug store building; thence with the outer edge of the wall of said building, approximately N. 23-46 E. 185.9 feet, more or less, to a point in line of J. E. Farr lot; thence S. 84-40 E. approx. 40.25 feet, which point is 6 feet southwest of the line dividing lot No. 5 on said plat; thence S. 23-46 W., through the center line of an 8 inch wall dividing the drug store and the doctor's office, 276.3 feet to a point on Cedar Lane Road; thence with Cedar Lane Road N. 70-20 W. 39 feet to the point of beginning; reserving, however, a strip twenty (20) feet in width at the rear of said lot, which strip shall remain open forever to be used as a driveway for the joint use of grantor and grantee, their heirs and assigns, for ingress and egress to this and other property.

ALSO, all my right, title, interest and estate in and to, that certain other lot and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Cedar Lane Road at the southeastern corner of Lot No. 5 and running thence with Cedar Lane Road N. 70-20 W. 22 feet; thence approximately N. 24-50 E. 290 feet, more or less, to a point in line of J. E. Farr's lot; thence S. 84-40 E. 44.625 to corner of lot No. 4; thence S. 28-45 W. 302.9 feet to the point of beginning, reserving, however, a strip twenty (20) feet in width at the rear of said lot, which strip shall remain open forever to be used as a driveway (description continued on reverse side)
