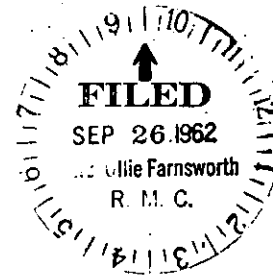

KNOW ALL MEN BY THESE PRESENTS, that I, Mary Breedin McClain

in consideration of Nine Thousand Five Hundred and 00/100-----(\$9,500.00)----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
James C. McMahan, his heirs and assigns, forever:

all that piece, parcel or lot of land, with improvements thereon, situate, lying and being in the County and State aforesaid, on the SE/s of Chestnut Ridge Road about 1.5 miles West of Marietta, S. C., being shown as Lots no. fourteen (14) and fifteen (15) on a plat of survey of Chestnut Ridge Park, made by Thomas C. Keith, September 24, 1955, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING in said Chestnut Ridge Road on joint front corners of Lots no. 13 and 14 and running with said road, N. 47-00 E., 150 feet to the joint front corners of Lots no. 15 and 16; thence with the common line of Lots no. 15 and 16, S. 56-30 E., 200 feet to an iron pin; (joint corners of Lots 15, 16, 61, 62); thence S. 47-00 W., 150 feet to an iron pin; (joint corners of Lots 13, 14, 59, 60) thence following the common line of Lots no. 13 and 14, N. 56-30 W., 200 feet to the point of beginning, being all of Lots no. 14 and 15 as shown on said plat, and being subject to such right-of-ways or easements as may have been previously given.

The above described property is a portion of the same conveyed to the grantor herein by deed of Othella Thornton, October 15, 1953, recorded in Book 487, page 176, and is subject to the protective covenants imposed on said property on Feb. 21, 1958, as recorded in the R. M. C. Office for Greenville County in Book 593, page 351.
