MAYE D. ROBERTSON, her heirs and assigns forever, all our right, title and undivided interest in and to

ALL that piece, parcel or lot of land with buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as LOT NO. 74, Section 1 of Oakcrest as shown by a revised plat made by C. C. Jones, Engr. dated August 1955, recorded in the RMC Office for Greenville County in Plat Book GG, pages 130 and 131 and having the following metes and bounds:

BEGINNING at a pin on the Eastern side of Templewood Drive at the corner of Lot No. 75 and running thence along the Eastern side of Templewood Drive along the curve thereof the following courses and distances: N. 10-53 E. 75.7 feet; N. 28-36 E. 46 feet to a pin at the corner of Lot No. 73; thence with the line of Lot No. 73, S. 61-24 E. 150 feet to a pin at the rear of Lot No. 75; thence with the line of Lot No. 75, S. 75-00 W. 173.6 feet to a pin, the point of beginning.
