unto H. L. Massey and Carrie W. Massey, their heirs and assigns forever:

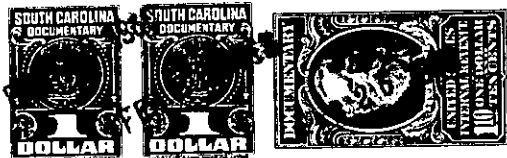

Office for Greenville County in Plat Book MM, at Page 55, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Earlene Drive, joint front corners of Lots Nos. 53 and 54 and running thence along the line of said lots, S. 88-05 W. 170 feet to iron pin; thence running with rear line of Lot 54, S. 1-55 E. 92 feet to iron pin rear corner of Lot 55; thence running with line of said lot, N. 88-05 E. 170 feet to iron pin on Earlene Drive; thence running with Earlene Drive, N. 1-55 W. 92 feet to iron pin point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty-five (35) feet to the front line; no residence shall be built on any lot unless said lot has 70 feet to more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
