the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto C. L. Hunnicutt, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being near the City of Greenville, being known and designated as Lot #27, as shown on a plat of Oakwood Acres, prepared by J. Mac Richardson, dated September 1959, recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 135, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Oakwood Avenue, the joint front corner of Lots #27 and #26, and running thence along the line of these lots, N. 22-55 W. 175 feet to an iron pin; running thence S. 67-05 W. 90 feet to an iron pin at the joint rear corner of Lots #27 and #28; running thence S. 22-22 E. 180.9 feet to an iron pin on the northern edge of Oakwood Avenue; thence along the northern edge of Oakwood Avenue, which line is curved, the chord of which is N. 62-24 E. 92.8 feet to an iron pin, point of beginning; being the same conveyed to me by Leslie & Shaw, Inc. by its deed dated August 3, 1962, and recorded in the R. M. C. Office for Greenville County in Deed Vol. , at page
