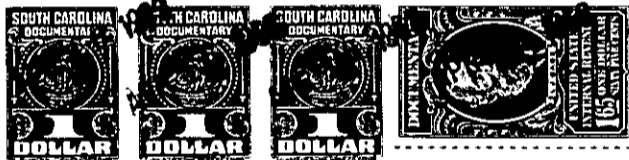

K. Campbell, R. L. S., dated July 9, 1962, and recorded in the Office of the R. M.
