in consideration of Fifteen Thousand Two Hundred & No/100 (\$15,200)----- Dollars,

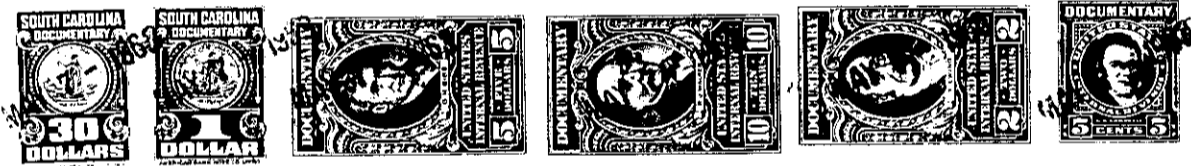
