Know All Men by These Presents:

That I, LeRoy Stroud, in consideration of the sum of One (\$1.00) and the premises

in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Kate Greer Dill and her heirs and assigns forever:

All of my right, title and interest, whatever the same may be, in and to all of that parcel or strip of land in Chick Springs Township of Greenville County, South Carolina, and being that parcel or strip of land which lies southeasterly from the center line of the Brushy Creek Road as presently located, contiguous to adjoining lands of the grantee.

WHEREAS, the grantor owns lands lying on the northwest side of the Brushy Creek Road and the grantee owns lands on the southeast side thereof, the parties hereto having a common line between them; and,

WHEREAS, changes have heretofore been made in the location of the Brushy Creek Road, making the common line of the parties uncertain as to highway frontage, it being the intent and purpose of this deed to make the center line of the Brushy Creek Road, as presently located, the fixed line between them and to quit-claim to the grantee any land necessary to make the highway the common line.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
