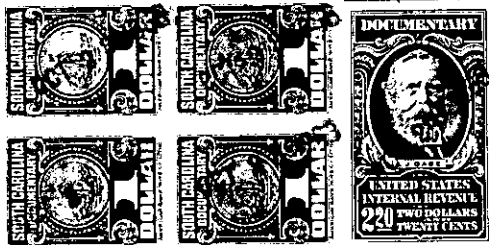
KNOW ALL MEN BY THESE PRESENTS, that we, Robert L. Goodlett and Elizabeth R. Goodlett,
