Office for Greenville County in Plat Book K, at Page 43, which plat is a resubdivision of Lots 1, 2, 3, 7, 8, 9, 10 and 11, of Block B, of Carolina Court, plat recorded in Plat Book F, Pages 96, and having according to the plat of the Lee property, the following metes and bounds, to-wit:
