in consideration of the sum of Three Thousand and no/100 (\$3,000.00) in the State aforesaid, DOLLARS,

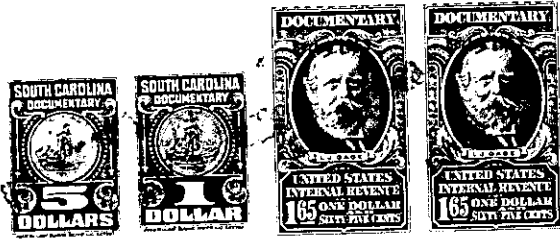
