the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and released unto Harriet Cleveland Dobbins, Gertrude Cleveland McCoin and Alice Cleveland Richardson, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, on the northern side of Pelham Road, being known and designated as Lot 4 of a subdivision of the grantors' property on Pelham Road and having, according to a plat entitled "Property of Harriet Cleveland Dobbins, Gertrude Cleveland McCoin and Alice Cleveland Richardson" prepared by Piedmont Engineers and Architects, September 30, 1963, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern edge of Pelham Road at the joint front corner of Lots 3 and 4, which pin is 1,040 feet measuring along the northern edge of Pelham Road, from the southeast corner of a lot belonging to Hungerford and running thence along the joint lines of Lots 3 and 4, N. 2-10 E. 440.0 feet to an iron pin on the line of other property belonging to the grantors; thence along the line of that property, S. 86-08 E. 300.0 feet to an iron pin at the joint rear corner of Lots 4 and 5; thence along the joint line of said lots, S. 11-98 W. 453.8 feet to an iron pin on the northern edge of Pelham Road; thence along the northern edge of Pelham Road, N. 80-39 W. 115.0 feet to an iron pin; thence continuing along the northern edge of Pelham Road, N. 86-28 W. 115.0 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants which are recorded in the R. M. C. Office for Greenville County in Deed Vol. 690 at Page 531, and is also subject to the following additional restrictions: (1) No building shall be located nearer than 100 feet to the front street line, and no building shall be located nearer than 25 feet to any side or rear lot lines; (2) No dwelling shall be erected on the above described property with the ground floor area of the main structure, exclusive of one-story open porches, breezeways, garages or carports, less than 2,000 square feet in one-story dwellings nor less than 1,500 square feet for a dwelling of more than one story.
