

ALL that piece, parcel or lot of land with all buildings and improvements thereon situate, lying and being at the Southerly corner of the intersection of Legrand Boulevard and Scarlett Street in the City and County of Greenville and being shown as LOT NO. 26 on plat of Sherwood Forest as recorded in the RMC Office for Greenville County in Plat Book GG, at pages 2 and 3 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwesterly side of LeGrand Boulevard, joint front corner of Lots 26 and 27 and running thence along the southwesterly side of said Boulevard, N. 49-11 W. 85 feet to an iron pin at the intersection of said boulevard with Scarlett Street; thence around said intersection on a courve, the chord of which is S. 81-41 W. 32.7 feet to an iron pin on the southeasterly side of Scarlett Street; thence along the southeasterly side of said Street, S. 32-34 W. 126.56 feet to an iron pin, joint corner of Lot 29; thence along the line of Lot 29, S. 49-11 E. 88.5 feet to an iron pin, joint corner with Lot 27; thence along the joint line of Lot 27, N. 40-49 E. 150 feet to the point of beginning.
