BEGINNING at an iron pin on the southeasterly side of County Cork Drive at the joint front corner of Lots 65 & 66 and running thence with the common line of said lots S. 52-40 E. 186 feet to an iron pin; thence S. 34-55 W. 75.3 feet to an iron pin; thence S. 45-25 W. 15 feet to an iron pin; thence N. 52-40 W. 186.7 feet to an iron pin on the southeasterly side of County Cork Drive; thence with said Drive N. 37-20 E. 90 feet to the point of beginning.
