to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Harold S. Strickland and Maxine L. Strickland, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 83 on a plat of Farmington Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Pages 106-7 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Manassas Drive at the joint front corner of Lots 83 & 111 and running thence with the common line of said lots N. 52-45 E. 170 feet to an iron pin in the line of Lot No. 84; thence with the line of Lot No. 84 N. 37-15 W. 110 feet to an iron pin on the southerly side of Shubuta Drive; thence with said drive S. 52-45 W. 145 feet to an iron pin; thence around a curve at the intersection of Manassas Drive and Shubuta Drive (the chord of which is S. 7-45 W.) 35.4 feet to an iron pin on the easterly side of Manassas Drive; thence with said drive S. 37-15 E. 85 feet to the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Farmington Acres and to the set-back line as shown on said plat.
