All that certain piece, parcel or lot of land, situate, lying and being on the southern side of Walker Springs Road, being known and designated as Lot #31 of a subdivision known as Coral Ridge, according to a plat prepared by Piedmont Engineering Service, dated March 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 119, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Walker Springs Road, joint front corner lots #31 and #32, running thence along the line of these lots, S. 3-50 W. 180.6 feet to an iron pin in the line of lot #30; thence N. 86-10 W. 90.0 feet to an iron pin on the eastern side of Coral Drive; thence along the eastern side of Coral Drive, N. 3-50 E. 150.6 feet to an iron pin at an intersection, which intersection is curved, the chord of which is N. 47-17 E. 36.3 feet to an iron pin on the southern side of Walker Springs Road; thence along the southern side of Walker Springs Road, S. 89-15 E. 65.0 feet to an iron pin, point of beginning.
