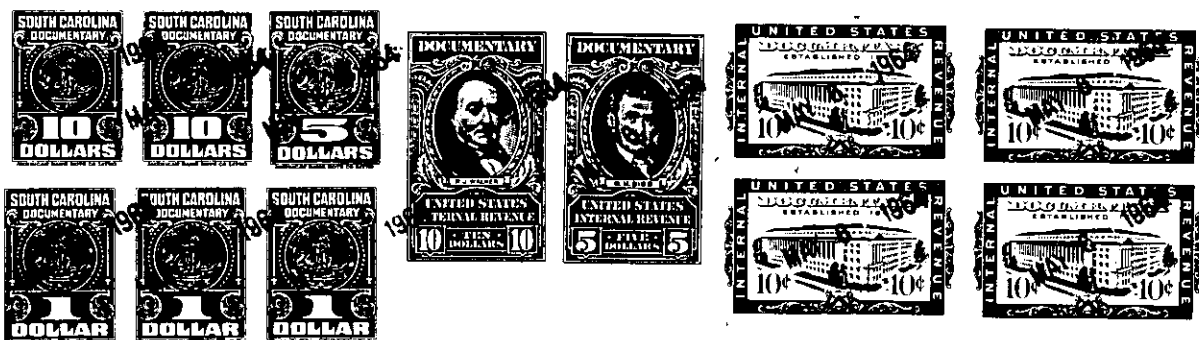

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #4 of a subdivision known as Welcome Acres, as shown on a plat thereof prepared by Piedmont Engineering Service, dated July 1963, recorded in the R. M. C. Office for Greenville County in Plat Book DDD, at Page 44, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Welcome Road, joint front corner lots #3 and #4, running thence along the line of these lots, N. 39-00 E. 170.5 feet to an iron pin in the rear line of lot #7; running thence along the rear line of lot #7, S. 52-23 E. 77.2 feet to an iron pin at the joint rear corner lots #4 and #5; running thence S. 37-09 W. 170.3 feet to an iron pin on the northern side of Welcome Road; thence along the northern side of Welcome Road, N. 52-28 W. 90.0 feet to an iron pin, point of beginning.
