to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mount. Vernon Mills, Inc., a Maryland Corporation, its successors and assigns, forever:

Parcel 1: All that certain piece, parcel or lot of land lying and being on the southwesterly side of U. S. Highway No. 276, near the Town of Simpsonville, in the County of Greenville, State of South Carolina, and having according to a survey plat made by H. C. Clarkson and R. K. Campbell, dated April 20, 1964, and recorded in the RMC Office for Greenville County, S. C. in Plat Book FFF, page 109, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly edge of the right-of-way of U. S. Highway No. 276, corner of Heyward Thompson property, and running thence with the right-of-way of said Highway S 36-09 E 858.5 feet to an iron pin, corner of property belonging to Kate Blakely, et al; thence turning and running with the line of the Kate Blakely property the following courses and distances: S 24-20 W 473.2 feet to an iron pin; S 10-13 W 400 feet to an iron pin; S 18-53 W 430.7 feet to an iron pin on the northeasterly edge of the right-of-way of Blakely Road; thence crossing Blakely Road and continuing on the same course S 18-53 W 496.3 feet to an iron pin on the northeasterly edge of the right-of-way of Neely Ferry Road; thence turning and running along a line in and through Neely Ferry Road the following courses and distances: N 31-20 W 150.6 feet to a point: N 25-50 W 336.6 feet to a point; N 16-50 W 231 feet to a point, and N 19-50 W 548 feet to a point on the line of property of Robert L. Thompson; thence turning and running with the Robert L. Thompson line and the Heyward Thompson line N 23-40 E 1339.6 feet to the point of beginning. property hereinabove described contains 27.79 acres, exclusive of the right-of-way for Blakely Road and the right-of-way for Neely Ferry Road, and this property is conveyed subject to the rights-of-way of said Roads, as shown on the plat above referred to.
