That I, J. Frank Williams

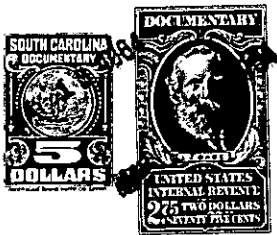
in consideration of the sum of Twenty Five Hundred and no/100 (\$2500.00) - - - - DOLLARS,

J. W. Pitts, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 5 on a plat of Oak Forest Subdivision, recorded in the RMC Office for Greenville County in Plat Book CCC, Page 41 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Oak Forest Drive at the joint front corner of Lots 5 & 6 and running thence with the common line of said lots S. 12-16 E. 129.6 feet to an iron pin; thence with the line of Lot No. 4 S. 78-49 W. 150 feet to an iron pin on the easterly side of Oak Forest Drive; thence with said Drive N. 12-16 W. 101.2 feet to an iron pin; thence around a curve in said Drive, (the chord of which is N. 33-0 E.) 35.1 feet to an iron pin on the southerly side of said drive; thence continuing with said drive N. 77-50 E. 125 feet to the point of beginning.
