That we, G. Hayes and Alice Shanklin Hayes, in the State aforesaid, in consideration of the sum of Ten (\$10.00) Dollars and other valuable consideration DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. J. Tapp and Frances D. Tapp the following-described property:

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, near the city limits of Greer, and being known and designated as Lot No. 8 on plat of Brookwood Subdivision prepared by B.B. Waters, Jr., Surveyor, October 14, 1958, and recorded in the office of the R.M.C. for Greenville County in Plat Book QQ, page 21, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Brookwood Drive, joint front corner of lots 8 and 9, and running thence along the joint line of said lots N. 87-27 W. 177 feet to an iron pin, joint rear corner of lots 8 and 9; thence along the rear line of lot 8 and a portion of the property of the Estate of J. V. Smith, S. 2-33 W. 100 feet to an iron pin, joint rear corner of lots 8 and 7; thence along the joint line of said lots, S. 87-27 E. 177 feet to an iron pin on the west side of Brookwood Drive, joint front corner of lots 8 and 7; thence along the west side of Brookwood Drive N. 2-33 E. 100 feet to the point of beginning. Being a portion of the property conveyed to grantors by Mrs. E. H. Shanklin by deed dated July 22, 1947 and recorded in the office of the R.M.C. for Greenville County in Deed Book 302, page 290.
