That P. D. Jarrard in the State aforesaid, in consideration of the sum of Six Thousand and no/100--(\$6,000.00)---- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

W. H. Jarrard, his heirs and assigns forever,

All that lot of land in Bates Township, Greenville County, State of South Carolina, on the Eastern side of Geer Highway (sometimes called Cleveland Street) in the village of Marietta, and described as follows:

BEGINNING at a stake on the Eastern side of Geer Highway 68 feet South from Slater Street at corner of property this day (June 1, 1948), conveyed to W. H. Jarrard, and running thence with the line of said property, S. 67-40 E. 175 feet to a stake; thence S. 22-20 W. 32 feet to a stake; thence N. 67-40 W. 175 feet to a stake on Geer Highway; thence with the Eastern side of Geer Highway, N. 22-20 E. 32 feet to the Beginning corner, together with the right to the use of a ten foot alley across the property of W. H. Jarrard.

Together with all of the Grantor's interest in the 10 foot alley across the property of the Grantee. Said alley is not a public alley and has been used only by the Grantee and the Grantor and it is intended that said alley shall be closed if the Grantee so desires.

Being the same property conveyed to the Grantor by deeds recorded in Deed Book 528 at pages 118 and 119.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
