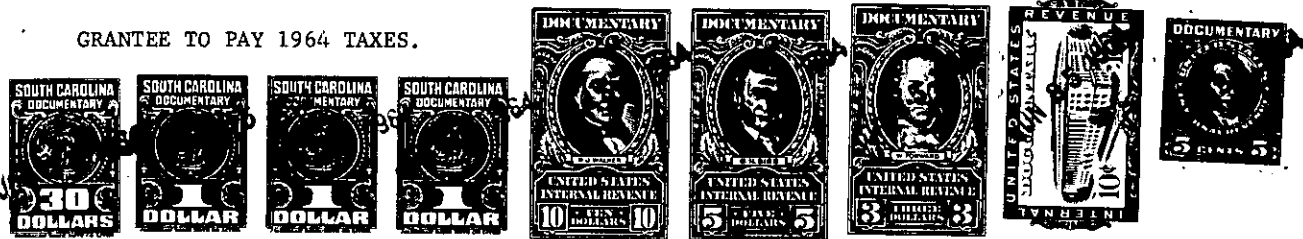
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southwesterly side of Farmington Road, near the city of Greenville, S. C. in Plat Book "QQ", page 83, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the southwesterly side of Farmington Road, said pin being the joint front corner of Lots No. 71 and 70 and running thence with the common line of said Lots S 48-27 W 211 feet to an iron pin in a branch; thence N 31-23 W 175.9 feet to an iron pin, the joint corner of Lots No. 74, 72 and 71; thence N 76-54 E 219 feet to an iron pin on the southwesterly side of Farmington Road; thence with the southwesterly side of Farmington Road on a curve S 31-12 E 70 feet to an iron pin, the point of beginning.
