our Lord nineteen hundred and Sixty Four exhibited her
complaint in the County Court for the County aforesaid, against

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard
on the 24th day of August 19 64
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and
decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for
the County aforesaid, to Stacy Mullis

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of
Greenville aforesaid, by virtue of the aforesaid decree, upon receipt of \$1,000.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
the said Stacy Mullis

All that certain parcel or tract of land in Greenville County,
South Carolina, located on the south side of State Highway No. 14 and
on the west side of Middle Tyger River, about fourteen miles north of
the City of Greer, being shown on a plat made for the C. S. West Estate
by J. Q. Bruce, dated June 18, 1963, and having the following courses
and distances:

BEGINNING on an iron pin in the center of said highway (old iron
pin on south bank thereof), and runs thence along the center of said
highway as follows: S. 88-35 E. 547.8 feet to an iron pin, N. 80-30 E
200 feet to an iron pin, N. 70-35 E. 200 feet, N. 59-40 E. 224.3 feet,
N. 48-40 E. 200 feet, and N. 43-35 E. 256 feet to a point in the center
of bridge over Middle Tyger River; thence down and with the meanders of
the river as the line, S. 12-30 E. 682 feet to a point (iron pin on
west bank of river); thence S. 82-05 W. 1341 feet to an iron pin;
thence N. 1-45 W. 309 feet to the beginning, containing 10.80 acres,
more or less, subject to the right-of-ways for highway purposes.
