ALL that certain piece, parcel, lot, or tract of land lying, situate and being in Grove Township approximately 250 yards West of Greenville-Greenwood Highway known as U. S. # 25 approximately 9 miles south of Greenville County Courthouse, and shown as Lot No. 1 on plat made by Terry T. Dill, Reg C. E. & L. S. No. 104, dated May 19, 1964.
