KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of Two Hundred Ninety Five & NO/100 (\$295.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. L. McDaniel and Mamie S. McDaniel, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Chick Springs Township, being known and designated as Lot No. 55, of a subdivision known as Holly Vista, as shown by a plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Woodbriar Road, joint front corners of Lots 54 and 55 and running thence along the lines of said lots, S. 45-12 E. 152.2 feet to iron pin line of Lot 60; thence running with line of said lot, N. 44-48 E. 50 feet to iron pin rear corner of Lot 56; thence running with line of said lot, N. 45-12 W. 160.4 feet to iron pin on Woodbriar Road; thence running with Woodbriar Road, S. 38-53 W. 50.2 feet to iron pin point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS deed is subject to all easements and rights of way of record.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
