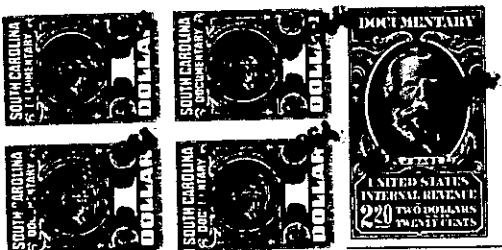
That I, JOHN BURRY,
