WHEREAS, O. Tommy Gibbs and Larry S. Frank each own a portion of Lot No. 7 of Property of Thomas T. Goldsmith as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "O", Page 41, the deeds to O. Tommy Gibbs being recorded in the R. M. C. Office for Greenville County in Deed Book 747, Page 114, and Deed Book 752, Page 314, and the deed to Larry S. Frank being recorded in the R. M. C. Office for Greenville County in Deed Book 752, Page 313, and

WHEREAS, it is to the mutual advantage of both parties that certain restrictive covenants be placed upon said property,

NOW, THEREFORE, in consideration of the premises and in further consideration of the mutual advantages accruing to each of the parties hereto it is agreed that Lot No. 7, Property of Thomas T. Goldsmith as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "O", Page 41, is restricted as follows:

- No building or structure of any description shall be located on the property nearer than 100 feet to the right-of-way line of White Horse Road. This shall not apply to signs advertising businesses located on the premises.
- All buildings located on this property shall be constructed so that all portions thereof which face or front on White Horse Road shall he faced with brick.

These Restrictive Covenants are imposed for the benefit of all owners of this property, including subsequent owners or purchasers, their heirs and assigns. These covenants are to run with the land and shall be binding on all parties or persons claiming under them until August 4, 1984.

If any person shall violate or attempt to violate any of the covenants herein contained, it shall be lawful for any other person, or persons, owning any portion of the above described real property to prosecute any proceedings at law or in equity against the person, or persons, violating or attempting to violate any such covenant, and either to prevent him or them from so doing or to recover damages by reason of such violation, or both. Invalidation of any one of these covenants by judgment, court order or otherwise shall in no way affect any of the remaining provisions.
