R. D. WILSON, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot # 1 of Shamrock Acres, Plat of which is recorded in Plat Book "YY", Page 43, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Farris Bridge Road, joint corner of Lots # 1 and 1A and running thence with the line of said lots, S. 30-40 W., 147.8 feet to an iron pin; thence N. 55 W., 100 feet to an iron pin on Kingswood Drive; thence with Kingswood Drive, N. 35 E., 100 feet to curve at the intersection of Kingswood Drive and Farris Bridge Road; thence with said curve, a chord of which is N. 74-58 E., 30.7 feet to a point on Farris Bridge Road; thence with Farris Bridge Road, S. 65-04 E., 70 feet to the point of beginning.
