the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

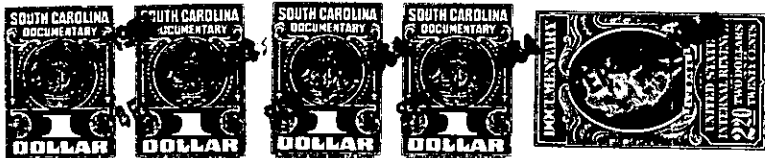
GENTRY B. AND MILDRED REESE, their heirs and assigns:

LOT NO. 19: BEGINNING at an iron pin on the southeast side of West Drive, 90 feet from the intersection of Jordan Drive, and running thence along West Drive, N. 42-06 E. 90 feet to the corner of Lot No. 20; thence along the line of Lot No. 20, S. 46-55 E. 180 feet to an iron pin; thence S. 42-05 W., 90 feet to an iron pin at the corner of Lot No. 18; thence along the line of Lot No. 18, N. 46-55 W. 180 feet to the beginning corner.

LOT NO. 20: BEGINNING at an iron pin on the southeast side of West Drive, 180 feet northeast of the intersection with Jordan Drive, and running thence N. 42-06 E., 85 feet to an iron pin; thence S. 84-45 E., 218 feet, more or less, to an iron pin; thence S. 52-05 W., 215 feet to an iron pin at the corner of Lot No. 19; thence along the line of Lot No. 19, N. 46-55 W., 180 feet to the beginning corner.

ALSO all my right, title and interest in and to that certain 2" water line serving the above described property.
