All that piece, parcel or lot of land in Greenville County, State of South Carolina, near Marshall Forest Subdivision, on the southern side of Brookside Way, being known and designated as Lot No. 1 of property formerly owned by Christie C. Prevost, and being described according to a plat prepared by the Piedmont Engineering Service, Greenville, S. C., dated July 5, 1949, and having, according to said plat, the following metes and bounds, courses and distances, to wit:

Beginning at an iron pin on the southern side of Brookside Way at the joint front corner of the property herein conveyed and lot now or formerly owned by Speegle, and running thence along the common line of said lots S. 25-30 E. 171 feet to an iron pin on the northern side of a five foot strip reserved by Christie C. Prevost, which strip is referred to on the aforementioned plat as Lot No. 3; thence along the northern side of said five foot strip S. 66-35 W 75 feet to an iron pin, the joint rear corner of Lots Nos. 1 and 2: thence W. 75 feet to an iron pin, the joint rear corner of Lots Nos. 1 and 2; thence along the common line of Lots Nos. 1 and 2 N. 25-30 W. 165.3 feet to a point on the southern side of Brookside Way; thence along the southern side of Brookside Way, a curved portion thereof, the chord of which runs N. 62-14 E. 75.2 feet to an iron pin, the beginning corner.

Brookside Way referred to above is also known as Riverside Drive.

The above described property is conveyed subject to the restrictions as set forth in detail in deed of Christie C. Prevost to William L. Bridges, recorded in Deed Book 386, Page 125, July 11, 1949 R.M.C. Office for Greenville County, South Carolina.
