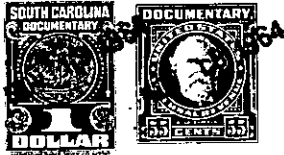

KNOW ALL MEN BY THESE PRESENTS, that We, Norman D. Griffin and Jimmie Gail Griffin

in consideration of Five Hundred Dollars (\$500.00) and the assumption of a mortgage set forth below Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Doris Eloise Dalton and Glenn Milton Dalton the following described property:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 as shown on the plat of Michael Park prepared by C. C. Jones, Engineer, dated August, 1961 recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book XX at Page 21, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Michael Drive at the joint front corner of Lots Nos. 2 and 3 and running thence with the line of Lot No. 2, N. 59-20 W. 140.8 feet to an iron pin in the line of property now or formerly of R. M. Kennedy; thence with the line of said Kennedy property, S. 30-46 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the line of Lot No. 4, S. 59-20 E. 155 feet to an iron pin on the northwest side of Michael Drive; thence with the northwest side of Michael Drive and following the curve thereof, N, 23-46 E. 52.2 feet to an iron pin; thence continuing with the northwest side of Michael Drive and following the curve thereof, N. 13-28 E. 27.2 feet to the point of beginning.

The above described property is the same conveyed to us by deed recorded in Deed Volume 739 at Page 193.

As part of the consideration, the grantee herein expressly assumes and agrees to pay that certain mortgage exacted by James N. Griffin to Carolina Savings and Loan Association, dated the 14th day of May, 1963 and recorded in the R. M. C. Office for Greenville County in Mortgage Volume 922 at Page 141.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
