R.M.C. in the State aforesaid, DOLLARS, One (\$1.00) and correction of title to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents a grant, bargain, sell and release unto the said Grace Methodist Church of Greer, its Successors and Assigns forever:

All that piece, parcel or lot of land

BEGINNING at an iron pin on the south side of the Taylor Road, corner of the lot above described, and running thence along the line of said lot, S. 8-27 W. 220 feet to an iron pin; thence in a westerly direction 125 feet to an iron pin; thence N. 8-27 E. 220 feet to an iron pin on the south side of the Taylor Road; thence along the south side of said road, S. 81-19 E. 125 feet to the beginning corner, and being the same property conveyed to Harold A. McFeely, et. Al., Trustees of Grace Methodist Church, by Earle Taylor by deed recorded in Deed Book 644, page 3, R.M.C. Office for Greenville County.

In trust, that said premises shall be held, kept, and maintained as a place of residence for the use and occupancy of the Ministers of The Methodist Church whom may from time to time be entitled to occupy the same by appointment, subject to the Discipline and usage of said Church, as from time to time authorized and declared by the General Conference and by the Annual Conference within whose bounds the said premises are situated. This provision is solely for the benefit of the grantee, and the grantor reserves no right of interest in said premises.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its Successors and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
