That I, Myra Smith Glasby in consideration of the sum of Two Thousand and No/100 (\$2,000.00)

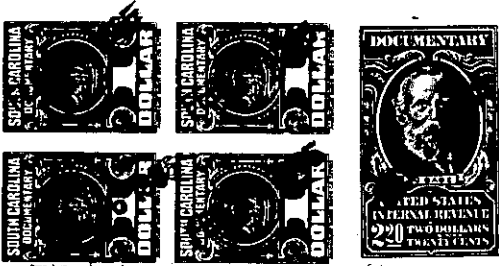
OLLIE FAYBOWORTH
