- - - - Paul R. Miller; his heirs and assigns, forever:

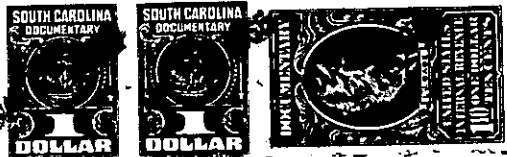
