

in consideration of the sum of EIGHT THOUSAND THREE HUNDRED SEVENTY & NO/100 (\$8,370.00) - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Constance P. Amspacher and William H. Amspacher, their heirs and assigns, forever:

All that tract of land in Butler. Township, Greenville County, State of South Carolina, on the northeastern side of Roper Mountain Road, near the City of Greenville, being shown on a Revised Plat of "Property of Emaly M. Greene" made by Dalton & Neves in December 1930, as revised September 1948, January 1951 and September 1956, and being described as follows:

"BEGINNING at a point in the center of the Roper Mountain Road, at the joint front corner of the 7.77 acres tract, and running thence with the line of the 7.77 acres tract, N. 45-55 E. 832.2 feet to an iron pin; thence N. 29-30 W. 289 feet to an iron pin; thence S. 45-55 W. 904.8 feet to a point in the center of the Roper Mountain Road; thence with said Roper Mountain Road. S. 11.05 E. 280 feet to the hosting road. Mountain Road, S. 44-05 E. 280 feet to the beginning corner."
