8. The general nature of the business for which the corporation is organized is (it is not necessary to set forth in the purposes powers enumerated in Section 2.2) (12-12.2 Supplemental Code 1962)

(a) Buying, selling, leasing, manufacturing and dealing generally in all kinds of radio, television and other electronic instruments, including leases, patents, rights and franchises; establishing, installing, maintaining, operating and leasing all kinds of receiving and sending television and radio stations in the State of South Carolina, and elsewhere as may be decided upon by the directors of the corporation; the doing of any and everything necessary and proper in the conduct of a general radio and television business.

(b) To do a general wholesale and retail business in radio and television equipment, supplies and accessories; to manufacture, repair, buy, sell, lease, import, export, and generally deal in all kinds of radio and television apparatus, equipment and appliances for the sending and receiving of radio and television messages; and also to manufacture, buy, sell, lease, import, export, and generally deal in machinery of all kinds, and such mechanical devices and engineering appliances as are generally manufactured, bought, sold, leased, imported, exported, and dealt in by manufacturers and dealers in a similar line of business; to construct, purchase, or otherwise acquire, deal in, sell, hire, lease, use, repair, operate and maintain radio and television equipment and apparatus of every kind and character whatsoever and all parts, appliances, accessories and machinery which are, or can be, properly used in connection therewith, or which may be adopted for the use in the construction of, upon, or in connection with the same; also generating and propelling apparatus, motor power and machinery therefor.

(c) To design, manufacture, install, purchase, or otherwise acquire, to sell or otherwise dispose of, and to generally deal in and with electronic transmitting and receiving sets and television transmitting and receiving equipment. To install, maintain and operate community antennas for the reception and transmission by cable or otherwise to receiving sets of broadcast radio and television signals and to install, maintain and operate closed circuit systems for the production, transmission and distribution of closed circuit signals and programs.

(d) To acquire, own, lease, rent and operate television and radio broadcasting stations, with any and all types of transmission facilities; to apply for, receive and hold all licenses that may be necessary or required from any licensing agency, ~~XXXXXX~~ federal, state or foreign; to do any and all things necessarily incident to the operation of such broadcasting or transmission stations, including but not limited to contracting for transmission of programs and entering into such other contracts as the board of directors of the corporation may, from time to time, deem proper and expedient.

(e) To acquire and pay for in cash, stocks or bonds of this corporation or otherwise the good will, rights, assets, and property of other corporations or businesses and to undertake to assume in whole or in part the obligations or liabilities of any firm, person, association or corporation whose assets are so acquired.

(f) To have one or more offices within or without the State of South Carolina and to acquire or hold and dispose of such real and personal property as may be necessary or convenient for the transaction of its business.

(g) To do everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects, or the furtherance of any of the powers hereinbefore set forth, either alone or in connection with other corporations, firms or individuals, and either as principals or agents, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid objects, purposes or powers or any of them.
