KNOW ALL MEN BY THESE PRESENTS, PHILIP N. BROWNSTEIN, of Wash-

ington, D. C., as Federal Housing Commissioner, Grantor, for and in consid-
eration of the sum of EIGHT THOUSAND AND 00/100-----DOLLARS
(\$8,000.00-----) ~~and other valuable considerations~~, has granted, bargained,
sold and released, and by these presents does grant, bargain, sell and re-
lease unto RONALD D. LESLEY AND EVELYN K. LESLEY

Grantee(s), and to the
heirs and assigns of said Grantee(s), the following described real estate
situate in the County of GREENVILLE, State of South Carolina, to wit:

All that lot of land in the County of Greenville, State of South Carolina, being known and
designated as Lot No. 251 on plat of Pleasant Valley subdivision, recorded in Plat Book "P"
at Page 92 of the PMC Office for Greenville County, South Carolina and having according to
said plat and a recent survey made by R. W. Dalton, October, 1957, the following metes and
bounds, to-wit: Beginning at an iron pin on the south side of Potomac Avenue, the front
joint corner of Lots Nos. 251 and 252; thence with the joint line of said lots, S 0-08 E,
238.4 feet to an iron pin; thence N 29-29 W, 124.2 feet to an iron pin, corner of Lot No.
250; thence with the line of said lot, N. 0-08 W, 130 feet to an iron pin on the south side
of Potomac Avenue; thence with the south side of Potomac Avenue, N 89-52 E, 60 feet to the
beginning corner.
