All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 9, Carver Park Addition, as shown on a plat prepared by Piedmont Engineering Service dated February, 1953, recorded in the R.M.C. Office for Greenville County in Plat Book DD, page 71 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Tuskegee Avenue at the joint front corner of Lots Nos. 8 and 9 and running thence with the line of Lot No. 8 N. 52-53 E. 105.4 feet to an iron pin; thence S. 22-02 E. 73.4 feet to an iron pin at the joint rear corner of Lots Nos. 9 and 10; thence with the line of Lot No. 10 S. 65-55 W. 94 feet to an iron pin on the Northeastern side of Tuskegee Avenue; thence along the Northeastern side of Tuskegee Avenue and following the curve thereof N. 31-02 W. 50 feet to the point of beginning.

ALSO: All that certain piece, parcel or lot of land being triangular in shape and adjacent to the rear portion of Lot No. 9 described hereinabove being known and designated as a portion of the area "reserved by owner" as shown on the plat of Carver Park Addition referred to hereinabove and having the following metes and bounds:

BEGINNING at an iron pin in the joint rear corner of Lots Nos. 9 and 10 and running thence along the rear line of Lot No. 9 N. 22-02 W. 73.4 feet to an iron pin at the joint rear corner of Lots Nos. 8 and 9; thence S. 36-54 E. 75 feet, more or less, to an iron pin; thence S. 65-55 W. 20 feet, more or less, to the point of beginning.
